


chart shows the total general purpose revenue Round Valley Joint Elementary School District expects to receive in the coming year from all sources.



Round Valley Joint Elementary School District is continuing to engage our educational partners for the use of the Expanded Learning Opportuinity Program and the TK expansion. RVJESD has a board approved plan for the Educator Effectiveness revenue.

Meaningful consultation with stakeholder groups (students, teachers, classified, SELPA Director, school leaders, and parents) took place in conjunction with LCAP development, during public board meetings, and surveys. The public has the opportunity to join RVJESD's monthly

board meetings in person or via Google Meet. At the August 11, 2021 School Board Meeting, the ESSER III funds were publicly discussed and it was decided that input from RVJESD's families would be gathered through a survey. Our families were provided surveys via Parent Square and 100% of the surveys favored upgrading classroom technology with the purchase of the Samsung Digital Flipchart Collaborative Display monitors and motorized carts to promote accessibility for students. Additionally, RVJESD's Resource Specialist will use IXL to create individual lessons to support students scoring "far below basic." Funding will provide 50 hours of push-in time to support the "far below basic" students which will equate to 6 hours spent in each of the K-5 classrooms.

Round Valley Joint Elementary School District has implemented all actions identified in our Elementary and Secondary School Emergency Relief (ESSER) III Expenditure Plan. Specifically, we have successfully implemented the Samsung Flip All-In-One Digital Flipchart Collaborative Display Monitors and the Resource Specialist has completed the fall benchmark assessments and has provided push-in-time to support those students "far below basic" students.

# Plan Summary [2022-23]

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Round Valley Joint Elementary School District has a long history in this rural community located outside Bishop and nestled in the Eastern Sierra. The school was originally established in 1871 to support mining families that lived out of town. The rich traditions and culture of a small school have been valued by the community over its near 150-year history. Round Valley School received recognition as a California Distinguished School in 1997 and again in 2020.

The school is a Community Funded school that also receives funding through the School District of Choice model which allows parents to apply for inter-district transfers. 35% of our student population travels the 22-mile round trip to attend this well respected school. The school's current demographics reflect 84% White, 11% Native American, and 3.7% Asian/Pacific Islander; 21% are of Hispanic origin. Fourteen students receive specialized services, 48% of our families are socioeconomically disadvantaged, and 1% of our students are English Language Learners. Beginning with the 2019-20 school year, Round Valley School discontinued its middle school and transitioned to a TK-5 school with a current student population of 59 and a teaching staff of seven, with two instructional aides, one custodial/maintenance/bus driver, a part time kitchen manager, an administrative assistant, and a Superintendent/ Principal. Our elementary students will continue to be served by highly qualified teachers and instructional aides. The school has purchased the latest curricular adoptions in Science, Math and English Language Arts which include intervention materials and curriculum designed to support unduplicated or underachieving students. Students are assessed using local measures, diagnostic tools, and state testing and the analyzed data directs where support is needed. We are very proud of the school's academic success as well as our ability to offer many extracurricular activities.

Round Valley School believes in providing a caring, safe and supportive learning environment where all students will be encouraged to achieve their full academic, social and physical potential. To accomplish this vision, we strive to provide meaningful educational experiences that keep pace with our rapidly changing society. While teaching a balanced curriculum, the uniqueness of each student is embraced. We model and expect ethical behavior and create an atmosphere of tolerance. Our success depends upon the partnership between the school community, family and child. Together it is our responsibility to support and develop the skills and qualities that lead to a confident caring life-

long learner. Most of all, we are proud that our school is one in which there is a highly personal feeling that exists among the students, staff, parents and community.

# **Reflections: Successes**

We feel that we have been completely successful with the implementation of the 2021-22 LCAP, despite the complications of the pandemic. Being a small staff with a small number of students to manage, we were able to provide the necessary educational resources to meet academic conditions and to monitor social emotional impacts on students and families. Our instructional aides provided one-on-one intervention sessions after school hours to support special education students. As measured by IXL and DIBELS, all students have demonstrated academic growth in ELA and Math. RVJESD was able to administer CAASPP assessments in the spring of 2021. 64.29% met or exceeded Standard for ELA and 57.14% met or exceeded Standard for Math.

# **Reflections: Identified Need**

Delving into the CAASPP scores, teachers have seen a need for writing support. This will be addressed through the implementation of Step Up to Writing in 2022 / 2023. DIBELS and IXL benchmarks will continue to be administered three times a year to assess student learning and monitor progress. We will continue to informed of upcoming events with increased use of our social media notifications. We will continue to provide Spirit Days as 90% of the students enjoy these days and we will look for inspirational themes to encourage the remaining 10% of students to participate. We will continue to promote trust and collegiality among staff by encouraging off site meetings and team building opportunities.

# **LCAP Highlights**

This year's LCAP will focus on accelerating and maintaining our grade level proficiency, maintaining a positive social-emotional learning environment, and providing a safe, secure and inviting learning environment. There are no major initiatives or facilities projects planned in the next three years.

Due to our small size (2021-22 enrollment is 59 students) and since we only serve TK-5 grade levels, the following metrics are not included in the LCAP:

Currently, Round Valley has less than 2% of the 59 students are identified as EL, homeless or foster youth students. Due to the small student body, in order to protect privacy, progress will be monitored on an individual basis and not reported in the LCAP. Our targeted unduplicated subgroup is our socio-economically disadvantaged student group which is represented by 48% of our students.

# **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Due to the pandemic, stakeholder engagement has been accomplished by providing families, staff and students with specific surveys, by providing the ability to attend monthly Board Meetings remotely, and by holding weekly staff/Union meetings with specific agenda items that look toward future goals. The Superintendent attended twice weekly Zoom meetings which included SELPA input. Parents attended several whole school Zoom meetings to share ideas and concerns about progressing through the pandemic. We also increased our parent communication letters to happen weekly to keep families informed of the many changes and responsibilities that came out of the pandemic. Our records indicate that we have reached 100% of our families with emails and texts on each delivery. Because our demographics are not diverse (no substantial subgroups except socioeconomically disadvantaged), we don't specifically hold committee meetings for EL students, for example, because we don't have any identified EL students and we receive limited specific funding for this subgroup. Instead, we focus on underachieving students from all subgroups when making goal decisions. Since our SED subgroup is 42% of our students, we are targeting a high population while at the same time serving all students with the same high quality instructional methods. Philosophically, we feel all students deserve the best we can provide and with our small class sizes ranging from 9 to 12, we can target any child in need.

A summary of the feedback provided by specific educational partners.

Our families have been very happy and supportive of the direction the school has taken during the pandemic and the fact that we were able to be back in seat in October 2020 and remained in-seat with no quarantines helped the school year seem "normal" to families and students. Surveys on the subject reflect this satisfaction. Parent input has driven changes in bussing, lunch distribution, lunch distribution sites, even drop-and-go student drop off and pick-up. Parents also feel that their children are safe and protected while at school according to survey results. As stated above, specific subgroups such as EL, homeless, and foster youth are not represented by committee as we have no identified students in these subgroups. Parent surveys are sent to all families and results are applied to all students. Treads shown by surveys are that parents are supportive of the academic success made by their students, that they are not interested in a summer school program, and that more families want bussing in their neighborhoods.

As a result of stakeholder input, our Extended Learning Opportunity Grant funding will focus on extending our school day next fall (no summer school) (Goal 1), purchasing a new bus(Goal 3, Action 4), and improving our tracking of academic success (Goal 1, Actions 1 & 2).

We need to accelerate and maintain this growth by continuing to monitor and utilize benchmark assessments and provide supplemental supports as needed.

# Goal Analysis [2021-22]

All actions in this goal area were implemented as planned.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Regarding 1.1, Software licenses were purchased for 3 years prior to 21/22. Regarding Goal 1.2, This cost is less due to a change in our data analysis structure that allowed us to utilize the Resource Specialist without creating additional expenses.

An explanation of how effective the specific actions were in making progress toward the goal.

IXL benchmarks revealed 100% of students demonstrated growth in math. DIBELS showed growth by all students, and demonstrated growth of up to an academic year by students receiving additional support from our resource teacher. The effects of Touch Math PD were inconclusive, however PD for Amplify was well received and necessary for the implementation of the new curriculum.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

There were no changes to the goal. However, metrics were added to better monitor benchmark assessments. (IXL and DIBELS). While there was no Dashboard in 20 / 21, school staff reviewed CAASPP results and our metric reflects the percent of students who met or exceeded standards in ELA or math. The only change to actions in this goal were to consolidate the professional development and describe current initiatives. #### **Required Descriptions**

Round Valley Elementary School is a single district TK-5 school with approximately 60 students. At this time, the district has fewer than 2% identified Foster Youth, Homeless or English Learner students. The actions in the LCAP that contribute to the increased or improved services requirement are provided on a school/LEA wide basis but are principally directed towards our unduplicated pupils; this student group is comprised of socio economically disadvantaged (SED) students. According to historic and current assessment data, our SED student group performs at a lower rate than their peers on both ELA and Math. Assessments data shows that the district's low income students require additional support to meet grade level proficiency, primarily in English Language Arts and mathematics. As a result, the school will continue to implement a more robust assessment system in order to provide timely and accurate formative data (Goal 1, Action 1). The results from the formative assessments will help teachers and staff provide more targeted and specific interventions for all students in the TK-5 school. The teachers will facilitate a process assessing and monitoring their progress. Similarly, since SED students perform at a lower level in math, teachers will be provided professional learning specifically to assist students with the writing process (Goal 1, Action 2). This continuous improvement process will allow staff members to improve academic outcomes for SED students resulting in an increase in academic performance as measured by benchmark and summative assessments.

Due to our geographic isolation, the district values offering students a wide range of experiences to promote character building, team building, and global awareness. This is accomplished through local field trips, assemblies, overnight learning opportunities and virtual field trips (Goal 2, Action 1) at low to no cost for families. This action is principally directed towards our SED families. We expect students to respond positively to school climate surveys and build their social emotional learning competencies. Along those same lines, teachers report that our SED students experience greater difficulty in self regulation in the classroom and have lower homework completion rates. In order to address these issues, the teachers will provide 30 minutes of mindfulness instruction per day (Goal 2, Action 4). We expect students to have greater capacity to engage with academics, increase in homework completion and fewer classroom disruptions that require administrator intervention.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Round Valley Elementary School's unduplicated student count represents approximately 48% of students which provides for a Minimum Proportionality Percentage (MPP) funding target of approximately \$41,397. This equates to an MPP rate of 9.45% for the 2022-23 school year. The actions described above benefit our high needs students. We identified that our SED subgroup falls in the below benchmark on our 2019 dashboard in both math and ELA. In order to address this, our data monitoring was streamlined so that this subgroup could be more closely tracked, and actions implemented. Realizing that alternate instructional supports may be needed, the instructional aide positions will focus on supporting these underachieving SED students. The instructional aide can utilize small group instruction, pull-out or push-in support, specialized instructional materials and software, and can modify classroom assignments to support student needs. The aides can also work with teachers on specific needs in the classroom to support accommodations and modifications. We expect, with regular progress monitoring and alternative approaches to instruction, that our SED subgroup can close the achievement gap.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
