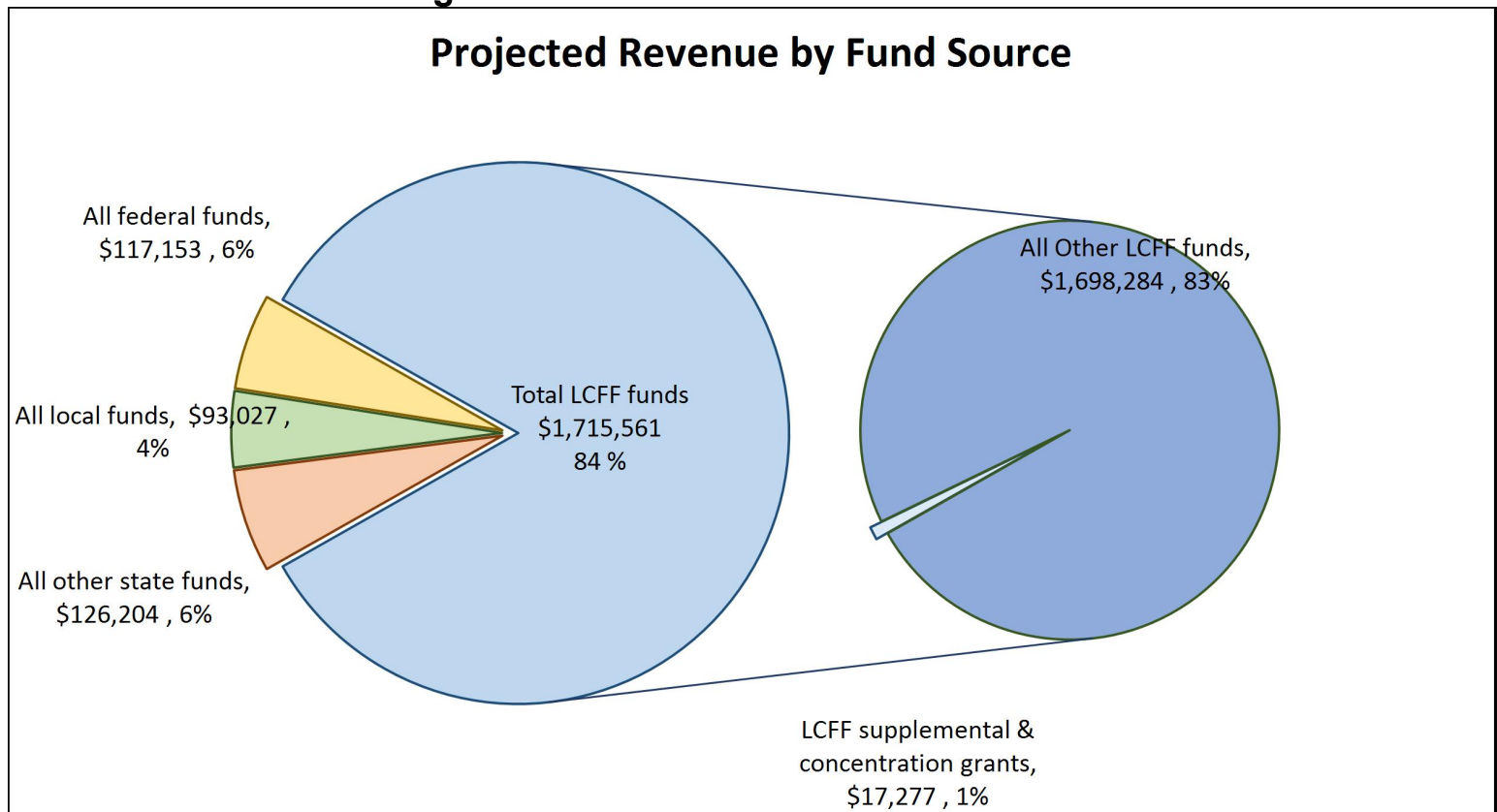

Budget Overview for the 2026-27 School Year

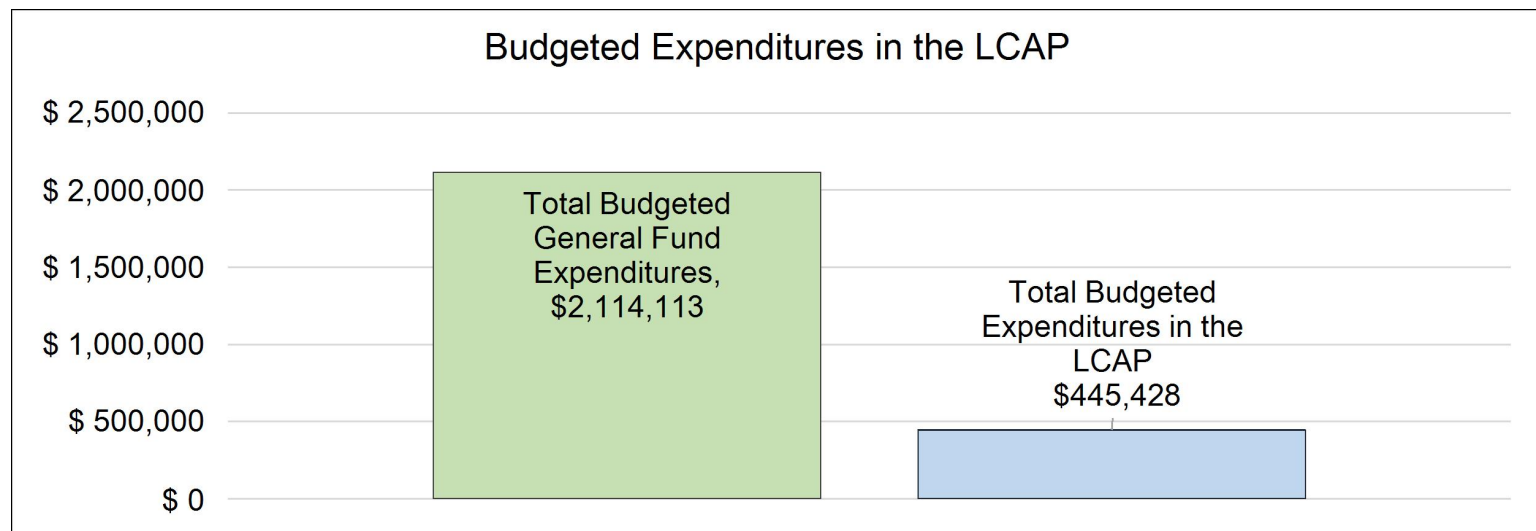


This chart shows the total general purpose revenue Round Valley Joint Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Round Valley Joint Elementary School District is \$2,051,945, of which \$1,715,561 is Local Control Funding Formula (LCFF), \$126,204 is other state funds, \$93,027 is local funds, and \$117,153 is federal funds. Of the \$1,715,561 in LCFF Funds, \$17,277 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

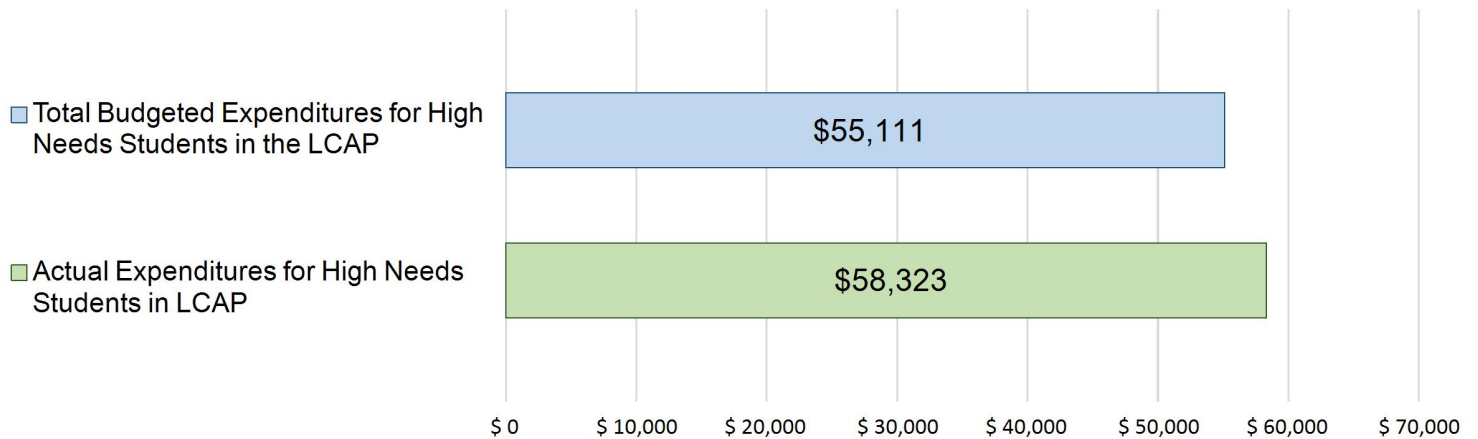
Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

In 2026-27, Round Valley Joint Elementary School District is projecting it will receive \$17,277 based on the enrollment of Foster Youth, English learner, and low-income students. General Information

Round Valley Joint Elementary School District has a long history in the rural Round Valley community. Located outside Bishop and nestled in the Eastern Sierra at the base of Mount Tom, the school was originally established in 1871 to support mining families that lived outside of town. The rich traditions and culture of a small school have been valued by the community over its 150+ year history. Round Valley School received recognition as a California Distinguished School in 1997 and again in 2020.

The school is a Community Funded / Basic Aid school that also receives funding through the School District of Choice model which allows parents to apply for inter-district transfers to Round Valley. Almost half of our student population travels 30 miles round trip to attend this well respected school; while several families travel 60 - 90 miles daily roundtrip. Beginning with the 2019 / 2020 school year, Round Valley School discontinued its middle school and transitioned to a TK-5 school with a current student population of 69, and a teaching staff of seven, with two instructional aides, one custodial / maintenance/ bus driver, a part time kitchen manager, an administrative assistant, and a Superintendent / Principal. Our elementary students are served by highly qualified teachers and instructional aides. The school has purchased the latest curricular adoptions in Science, Math and English Language Arts which include intervention materials and curriculum designed to support unduplicated or underachieving students. Students are regularly assessed using benchmarks, diagnostic tools, and state testing. Analyzed data reveals where support is needed. We are very proud of the school's academic success as well as our ability to offer many extracurricular activities.

Round Valley School believes in providing a caring, safe and supportive learning environment where all students will be encouraged to achieve their full academic, social and physical potential. To accomplish this vision, we strive to provide meaningful educational experiences

that keep pace with our rapidly changing society. While teaching a balanced curriculum, the uniqueness of each student is embraced. We model and expect ethical behavior and create an atmosphere of tolerance. Our success depends upon the partnership shared amongst the school, community, family, and student. Together it is our responsibility to support and develop the skills and qualities that lead to a confident, caring, life long learner. Most of all, we are proud that our school is one in which there is a highly personal feeling that exists amongst the students, staff, parents and community.

Due to the district's small size and limited number of EL students the English Learner Progress Indicator (ELPI) and reclassification rate will not be publicly provided. The district does not include a high school so the following metrics are not included: AP passage rates, CTE completion, graduation, dropout rate, College & Career Indicator. RVJESD is a TK-5 school thus we will not have a middle school dropout rate.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Although Chronic Absenteeism has decreased and we continue to have strong daily attendance which averages 93.3%. The district also continues to have zero suspensions and zero expulsions. As indicated by the Dashboard, Round Valley has increased the points above standard for ELA and increased points above standard for mathematics. The district's staff will continue to use local data in addition to CAASPP results to monitor progress in ELA and Math. Family involvement is something the district values and 98% of families attend Back to School and Open House events. According to the 2023 Dashboard there were no schools or student groups at the lowest performance level. The District will be expending the new Learning Recovery Emergency Block Grant Funding by purchasing updated math curriculum. (Goal 1 Action 1.6) The LREBG action will be monitored using math CAASPP data metrics 1.3 and 1.4 in Goal 1.

Through surveys from parents the Principal/Superintendent learned that families are interested in RV offering 6th - 8th grade. The teachers provided input that additional curricular materials were needed to support a robust, comprehensive math instructional program (Action 1.6). Based on staff feedback, step up to writing continues to be an area of focus for the district basaed on students need (Metric 1.1. and Action 1.1) As an enrichment opportunity, we continue to offer an Art of Cooking class and a sewing class (Action 2.1). Thge school's culture and climate is positive as reflected by staff and parent comments / surveys.

The 2023 CAASPP scores for grades 3-5 show that there was a decline in distance from standard for both ELA (declined 13.7 points) and Math. Although our the benchmark assessments continue to show student growth, there are 40-50% of students scoring below grade-level proficiency. With a continued focus on providing intervention and small group instruction, we would expect to see growth in the CAASPP metrics and benchmark data.

The actions were implemented as planned. While teachers and parents have commented on students' benefits from our new math and language arts intervention groups, staff would benefit from increased math training and new math curriculum.

We feel the actions are effective because both our math and ELA scores increased. The number of students that met or exceeded the standards increased as did students above standard on the Dashboard.

Actions #1 - 5 will stay the same. There will be no changes to Goal 1 or the metrics. However, target outcomes have been adjusted to reflect increased opportunities for growth. Action 6 has been added to reflect an updated math curriculum that supports the 2023 math framework and will help guide the teachers in focusing on shifts in math pedagogy.
